CALL TO ORDER: Jones called to order 7:00pm.

PLEDGE:

ROLL CALL: Jones, Supervisor; Runyon, Clerk; Riske, Treasurer; Dawson, Trustee; Haire, Trustee.

GUESTS: Julie Alexander, County Commissioner, Dan Funston, Superintendent for Concord School, Jason Blossom, Bill Brigham and many Township residents.

- * Dan Funston gave an overall view of the Concord School Millage proposal on the ballot for the coming election.
- * Julie Alexander said she was working hard for all of us. One of the things was they were working on lowering no fault auto insurance premiums.
- * Jones said we were going to have a community meeting regarding whether commercial medical marihuana operations should be allowed in our township.

CONSENT AGENDA: Motion made by Riske supported by Dawson to accept corrected amount of bills, and regular September minutes. Carried

TREASURERS REPORT: It was the consensus of the Board to receive and file the Treasurer's report for September 2017.

UNFINISHED BUSINESS: Riske gave report on the playground. Because of scheduling difficulties we are going to start in the Spring of 2018. Deadline for grant usage is March 31, 2019.

- * Playground Committee will do a conference call October 18, 2018 at 7:00pm with Playground Equipment Manufacturer.
- * Riske introduced Melissa Stroede, representative for County National Bank. Stroede presented Pulaski Township with a check for \$11,300.00 as a donation towards the new playground.
- * It was decided to do maintenance and clean up for the Township office and fire department building October 14, 2017 at 8:30am.

COMMISSION REPORT: Total runs for September, 27: EMS 22; PI 2; AA 2; Fire 1. Total active 15 members and 1 cadet.

New Business: Fire Club bought a gas detector at a price of \$600.00

- * The new lettering has been put on the new engine.
- * Motion made by Riske to hire three (3) new applicants for the fire department pending physical and drug screen. Supported by Dawson. Carried
- * Two (2) applicants will start out as Cadets and the third as a firefighter.
- * Motion made by Jones to allow the Fire Chief to spend up to \$100.00 without immediate Board approval. Supported by Riske. Carried.
- * Jones questioned fire chief regarding number of runs for the month. He said he would check into it

and get back with the board.

NEW BUSINESS: Board Members were not interested in going to MTA Accounting and Payroll seminar.

- * Consensus of the Board to have a Community meeting November 9, 2017 at 7:00pm to gather public input on whether commercial medical marihuana operations should be allowed in the Township. Meeting will be held at the Township Hall.
- * Millage committee will meet October 18, 2017 at 7:00pm.
