CALL TO ORDER: Jones called to order 7:00pm.

BRIEF PUBLIC COMMENTS: Ralph Riley explained about his proposal to install skid mount pump assembly.

CONSENT AGENDA: Motion made by Dawson supported by Runyon to accept corrected amount of bills, and minutes for regular March Board Meeting. Carried

TREASURERS REPORT: It was the consensus of the Board to receive and file the Treasurer’s report for March 2018.

CORRESPONDENCE: Runyon asked if anyone was interested in going to a cemetery class or a class on the Fundamentals of Assessment and Taxation given by MTA. Board members were not interested in going at this time.

UNFINISHED BUSINESS: Motion made by Riske Supported by Runyon to accept proposal from Lammers to replace furnace with 59SP5A60 96% 60,000 BTU gas furnace in office area for \$2,865.00. Carried by 4 and 1 Nay by Haire. Carried

NEW BUSINESS: Motion made by Riske to approve Comco LLC. application for medical marihuana grower class C and processor licenses. Supported by Runyon.

- * Motion made by Runyon, supported by Dawson to amend the building permit inspection fees to add fire-safety inspection \$50. Carried
- * Motion made by Riske supported by Runyon to increase fees for Zoning changes to \$250.00 and Board of Appeals hearing to \$250.00. Carried.
- * Bob Jones the Township Supervisor said he was stepping down in July from Zoning Compliance Officer and we should start looking for someone else.

COMMISSION REPORT: Chief Riley gave report. Total runs for March, 14: EMS 12; AA 1 (Concord); Fire 1. Total active 15 members and 2 cadets.

- Business: Chief Riley's class for Fire Officer will be ending May 13, 2018.
- * Chief Riley will take \$4,300 out of Capital purchase to pay for their share of the \$8,600 DNR Grant to upgrade the fire pump skid unit in the grass rig.
 - * The following items have been received: wheel chocks for the trucks, low level strainers for suction, and ice rescue gear (on backorder).
 - * SCBAs have been flow tested.
 - * Riley will get prices on paneling for the upstairs and present it next meeting.
 - * Fire department invited the township to a pig roast on April 21, 2018 from 2 to 6. Township residents can also ask any questions that they may have about the upcoming millage.
 - * Haire made a motion to purchase skid mount pump assembly from Riley Apparatus for \$8,600.00. Dawson supported. Carried.

BILLS: Motion made by Runyon to pay April bills as presented for \$29,076.63 plus 1 WOW, 2 Consumers, and Citgo. Supported by Riske. Carried

PUBLIC COMMENTS: Joseph Kormos Jr. talked about the open meetings act.

- SUPERVISOR'S NOTES: Jones said there will be on May 1, 2018, a special meeting to discuss proposed ordinance amendments pertaining to the new Medical Marihuana Ordinance. Notice will also be published in the Salesman twice.
