

PULASKI TOWNSHIP REGULAR BOARD MEETING MINUTES

CALL TO ORDER: Jones called to order 7:00pm.

PLEDGE:

BRIEF PUBLIC COMMENTS: Several residents were commenting on low culvert on Lippert Rd. Water comes up from Swains Lake Drive. Al Tompkins, County Commissioner, was here and talked with the residents about the culvert. He said he would talk to the County again. Jones will set up a meeting with Drain Commission and other officials that would be involved in trying to get this problem resolved.

CONSENT AGENDA: Motion made by Jones supported by Riske to accept corrected amount of bills, and Regular August Board Meeting, minutes. Carried

- * Riske made a motion to have Bruce A. Little for Pulaski Township new Assessor at a rate of \$14.00 per parcel starting November 1, 2018. Sheryll Dishaw will be leaving October 30, 2018. She will be truly missed.
- * Jones talked to Bob Griffis, (JDOT) about replacing pipe and cement in front of fire barn by road. Griffis said it was our problem because they didn't replace them if we are commercial. Griffis did say he would get us a strap to hold pipes together where they are broken. Jones will get 2 estimates to replace cement.
- * Motion made by Jones to ok PA116 for Greg, Cynthia, Brent, and Lynda Hotchkin with corrections to questions 1 and 9 in his application. Supported by Riske. Carried. Next step Runyon will make corrections and send them to the State.
- * Jones received the new Buck Cemetery sign.

- * It was the consensus of the Board to accept Comco invitation to tour his dispensary center.
- * Riske will call IT Right and set up an appointment for us to talk to them regarding the service they offer.
- * Motion made by Jones, supported by Runyon to pay \$560.25 for our 2019 membership for Region 2 Planning Commission.
- * Motion made by Runyon to amend Elections Maintenance/Repair in the amount of \$900 from Contingency. Supported by Riske. Carried.
- * Motion made by Runyon to amend Election Office Supplies in the amount of \$500 from Contingency. Supported by Riske. Carried.

BILLS: Motion made by Runyon to pay October bills as presented for \$19,791.13 plus Citgo and, 2 Consumers. Supported by Riske. Carried
