CALL TO ORDER: Jones called to order 7:00pm.

COMMISSION REPORT: Dale Jordon gave report. Total runs for May, 10: EMS 7; AA 2; Fire 1. Total active 17 members and 2 cadets. Total runs for the year 52.

Business: Grass rig skid mount pump that was ordered is on back order.
